Summary of Module

The module examines a broad range of topics within policing: from the history of policing in Britain to the role and functions of the police and other agencies in policing contemporary society. In engaging with these topics we will explore the various approaches and strategies of policing that underpin and influence policing practice such as routine patrol; community policing; problem-oriented policing; intelligence-led policing, and performance management.

The module also examines the means by which individual officers account for their professional conduct and the systems through which police forces are held accountable for policing practice and outcomes. Moreover, the module also engages with themes of established and current relevance in the study of policing, including: police culture and the use (and abuse) of police discretion; the role of the media in representing the police and policing; the pluralisation of policing, including both the rise of private policing and the role of civilian police staff; and the growth of transnational policing.
