Summary of Module

This module focuses on the leadership and managements skills that are essential qualities of Nursing and Midwifery (NMC) registrants in the United Kingdom. The NMC Standards of proficiency for registered nurses will be the foundation of the module content with students having the opportunity to critically appraise and analyse models of multidisciplinary teamwork in the United Kingdom. Students will develop a critical understanding of the skills for building effective teams, this will be related to the demonstration of effective professional communication, problem solving and decision making skills.

The associated skills acquisition contributes to the development of UWS Graduate Attributes: Universal – critical thinking, analytical, inquiring, culturally aware, emotionally intelligent, ethically-minded, collaborative, research-minded and socially responsible; Work –Ready – knowledgeable, digitally literate, effective communicator, motivated, potential leader; and Successful – autonomous, incisive, creative, resilient and daring.
