Candidates must be able to satisfy the general admission requirements of the University of the West of Scotland as specified in Chapter 2 of the University Regulatory Framework together with the following programme requirements:

Appropriate Undergraduate Qualifications:

Applicants will typically possess a degree or equivalent. In the absence of a degree, where entry requirements do not conform to the general entry requirements, other evidence can be considered on an individual basis in line with Regulations 2.13 – 2.36 (Recognition of Prior Learning – RPL / Recognition of Credit).

Applicants should normally possess a health related degree or equivalent.

Other Required Qualifications/Experience

Admission is permitted with relevant previous academic credit and/or prior learning in accordance with University of the West of Scotland Regulatory Framework, Chapter 2. Applicants must also have the language and literacy skills as per Chapter 2 Reg Framework. Applicants may also be considered with other academic, vocational or professional qualifications deemed to be equivalent.

Skills and experience in Information Communication Technology

General Overview

The overall aim of the programme is to provide the opportunity for students within the multidisciplinary context to further develop their knowledge, skills and expertise relevant to health studies. It is anticipated that students undertaking this degree will already have considerable professional expertise and knowledge. The programme builds on the skills of research, information dissemination and practice previously developed in undergraduate programmes.

These modules are set within a framework of interrelated themes of:

- Contemporary Issues Role Enhancement Evidence Based Practice
- Reflective Practice.

Students normally complete the three core modules, in addition to three option modules, in the order stated above prior to commencing the MSc Dissertation (HLS) module (60 SCQF level 11 credits). Students will be eligible for the award of MSc Health Studies (at least 180 credits of which a minimum of 150 at SCQF 11 and none less than SCQF level 10) by successfully completing the MSc Dissertation (HLS) module in a subject related to their field of practice.

Successful completion of the above two core and one option modules, in addition to three modules under Pg Certificate Health Studies (total 120 credits, of which a minimum of 90 are at SCQF 11 and none less than SCQF level 10, in accordance to UWS reg 1.21) or other relevant postgraduate certificate such as PG Certificate in Child Protection, PG Certificate in Learning and Teaching in Higher Education, are required for the award of Pg Diploma Health Studies. Following approval from the Programme Leader, additional relevant modules from other programmes that meet the learning outcomes of this programme may also be used as optional modules. Distinction will be awarded to awards of Diploma in line with University Regulations, Chapter 3. Before commencing the MSc Dissertation(HLS) Module, students normally complete all core and option modules in PG Cert and PG Diploma modules and

accrued 120 credits of which a minimum of 90 are at SCQF 11 and none less than SCQF level 10, in accordance to UWS reg 1.21

Students who have undertaken the PgC Child Protection and wish to transfer credit to the Postgraduate Diploma in Health Studies will require completing the coremodule Responding to Public Health Challenges (PgC) and 2 core modules within the Pg Dip.

On successful completion of the MSc Dissertation (HLS) module and having achieved in total of 180 credit points of which a minimum of 150 at SCQF 11 and none less that SCQF level 10 the student will be eligible for the award of MSc.Health Studies in accordance to UWS REG 1.21. Distinction will be awarded in line with University regulations, Chapter 3.

Regulations of Assessment

Candidates will be bound by the general assessment regulations of the University as specified in the <u>University Regulatory Framework</u>.

An overview of the assessment details is provided in the Student Handbook and the assessment criteria for each module is provided in the module descriptor which forms part of the module pack issued to students. For further details on assessment please refer to Chapter 3 of the Regulatory Framework.

To qualify for an award of the University, students must complete all the programme requirements and must meet the credit minima detailed in Chapter 1 of the Regulatory Framework.

Combined Studies

There may be instances where a student has been unsuccessful in meeting the award criteria for the named award and for other more generic named awards existing within the School.

Provided that they have met the credit requirements in line with the SCQF credit minima (please see Regulation 1.21), they will be eligible for a Combined Studies award (please see Regulation 1.61).

For students studying at Level 11, they will normally be eligible for an exit award of PgCert / PgDip / Masters in Combined Studies.
