Summary of Module			
This module will examine legal issues in Public International Law. It will provide students with an introduction to the law in this field. It will show who can formally act and make law in the international plane: states and IGOs, and the necessary requirements for each. It will look at what types of law exist: sources of law. How this law applies and assess its effectiveness. It will look at international humanitarian law and the laws of war, and how law can help resolve disputes in these areas. It will also look at any contemporary or historical developments in the law, and issues and debates in this field. This module will be delivered by way of 11 2 hour workshops.
