The module enables students to develop the research and analytical skills required of modern business professionals and accounting and finance specialists. Students will learn how to idenfiy a research problem to be investigated; develop a strategy to collect information; collect and critically analyse a range of resources; consider alternative research designs; demonstrate a critical awareness of data collection issues and consider the ethical implications of conducting research. Students will also develop personal and communication skills by presenting their work.
