#### **Summary of Module**

This module is an introduction to the making of cinematic documentary films. It is a practical filmmaking module, supported by a theoretical and contextual overview of the practice of making documentary films today. The module will also consider historical developments and offer a basic analysis of divergent contemporary forms, ethics, and key questions within documentary filmmaking.

The intention of the module is to encourage students to see the documentary film as an opportunity to produce creative, emotionally involved stories. The module is an opportunity to discover how the modern documentary film made with modest means can be just as creative, engaging, and exciting as any mainstream cinema.

The module will be delivered through a programme of lectures, screenings, and seminars, as well as practical workshops and development tutorials. Students will participate in short group production exercises, taking on a range of production roles. These roles will rotate wherever possible. Students will initially research, produce, and present a proposal for a short observational documentary film.
