This module will introduce students to varying definitions and theoretical approaches to social work. Within this module students will explore the historical foundations of Social Work and landmark developments in policy and practice, up to and including the current policy and practice context within Scotland. Students will examine the application of social work ethics and values to social work practice; this will include anti-oppressive and antiracist perspectives.
