Summary of Module			
<p>This module introduces and critically explores the intricate relationships between language, culture, and the concept of citizenship in a transnational world. Students will examine key theories of inter- and cross-cultural communication, considering how and to what extent cultural differences impact communication practices and the interpretation of messages. The module will address topics such as the question of culture, language in culture, intercultural dialogue, language and the nation, linguistic citizenship, and the role of language in fostering social cohesion and understanding in a multilingual world. Through case studies and practical activities, students will develop an understanding of the issues relevant to creating an inclusive learning environment and society. By critically reflecting on their own cultural assumptions and engaging with diverse perspectives, a range of media, and digital resources, students will gain insights into the role of language in promoting inclusive and agentive citizenship</p>
