Summary of Module	I						

A fundamental role of the dental nurse is supporting patient care and the dental team as they engage in a range of clinical skills to support routine and non-routine dental treatment.

The student's competence will be assessed within a clinical environment demonstrating evidence of clinical skills and professionalism. The student must reflect against clinical standards and demonstrate competence at the appropriate level for General Dental Council registration.
