<b>Summary of Module</b>			
<p>Technology is being used widely to ensure individuals can remain at home for longer and when necessary receive safe, efficient and effective health care. These technological, medical and societal changes have transformed how health and care services are delivered. Multiple strategic documents acknowledge this transformation in care delivery and signal that the health and social care workforce needs to be ready to work with people using technology in a variety of contexts, for example: home monitoring, virtual wards, Attend Anywhere/near me.</p> <p>This module will be attractive to all health and care professionals working and supporting people using digital technologies. The module will facilitate the development of the student's knowledge and skills in undertaking structured, safe, effective, person centred/led assessment from a distance by focusing on the core skills of communication and decision making. Students will practise and develop these skills during the module and utilise reflective and group discussions to consolidate their learning.
