## Admissions Criteria

Candidates must be able to satisfy the general admission requirements of the University of the West of Scotland as specified in Chapter 2 of the University Regulatory Framework together with the following programme requirements:

**SQA National Qualifications:**

- Applicants to the full-time version of the programme at NCL should have completed an SQA Higher National Diploma (HND) in a relevant programme of study, such as HND Business, Administration, Management, Leadership, Marketing, Accounting, Travel and Tourism, Hospitality etc. Entry to the degree with alternative titles will be subject to the programme leader's approval following matching of content.
- Applicants with non-Scottish based qualifications will also be considered provided these are at an equivalent level of study and that the programme title and content is relevant. Where there is any requirement to match content, this will be the responsibility of the programme leader.
- Applicants for part-time entry to the programme should also have completed an SQA HND in a relevant programme of study, such as HND Business, Administration, Management, Leadership, Marketing, Accounting, Travel and Tourism, Hospitality etc. Entry to the degree with alternative titles will be subject to the programme leader's approval following matching of content.
- Prior experiential learning in respect of Recognition of Prior Learning (RPL) and/or Accreditation of Prior Learning (APL) will also be considered for entry to the NCL-based programme for applicants, subject to UWS requirements for entry on this basis. ### **General Overview**

The BA (Honours) Business and Sustainability provides you, as a student, with an opportunity to study towards a degree in business that concentrates not only on general areas of the business sector but also focusses on critical issues that affect our planet and its survival. Sustainability is now recognised as a crucial element of modern business practice and key to future development.

The protection of biodiversity, grasping the impact of climate change and understanding its implications and how to reverse this, whilst also dealing with poverty and social inclusion, is considered essential to our future and to that of generations to come.

Within business there is growing attention being given to these issues and on how businesses can both cause and reverse the alarming negative trends faced the planet and its inhabitants. This programme will help to provide you with a deep understanding of the key issues and encourage you to use your skills to look at how business practice can work in tandem with sustainability to improve outcomes for the planet.

Businesses and increasingly recognising the importance of sustainability practices and there has been rapid growth in the employment market for students who have skills in this area, with recent job advertisements in the West of Scotland alone looking for graduates to fill sustainability roles such as analysts, consultants, and/or advisors to business. These well-paid roles included full-time, part-time, and internship options (Google Search 7 October 2023 using 'business sustainability jobs').

Sustainability is a global concern, and it is expected that, as a graduate, you will have developed skills that make your degree attractive to employers across the business world, whether large multi-nationals, small to medium sized enterprises, charities, or other relevant organisations.

The skills included in your degree reflect market expectations of a business degree and those of the Quality Assurance Agents (QAA) which oversees university degree programmes.

Study on this top-up programme will be offered at the UWS University Centre which is situated on the Cumbernauld Campus of New College Lanarkshire and is available to students who have previously completed a relevant SQA accredited HND programme or an equivalent qualification from elsewhere in the United Kingdom that meets SCQF level 8 specifications therefore allowing you to complete a degree in two years (for Honours) or one year (for Ordinary degree) on a full-time study basis. Alternatively, you may be able to complete in four years (for Honours) or two years (for Ordinary degree) on a part-time basis. All part-time study routes will be on a daytime in-fill attendance basis, with part-time students attending daytime modules along with full-time students.

Students who have prior experiential learning will also be considered for part-time entry and should contact the programme leader for information and advice.

### **Further Study Opportunities**

On completion of your degree, you may wish to study at postgraduate or Master's levels at UWS in our business related programmes, either on a full-time or part-time basis. On completion of this, you may even choose to study towards completion of a doctorate.

### **Typical Delivery Method**

The BA (Hons) Business and Sustainability programme uses a wide range of learning, teaching, and assessment methods to help you attain the learning outcomes requirements of the programme.

Modules use methods that are appropriate to their learning outcomes. These will help you to develop employability and interpersonal skills and encourage you to reflect on what you have learning and how you can build transferable skills such as managing timescales and tasks, working with others, negotiating, etc.

In your first year of study, level 9 (year 3 of the degree – your entry qualification will be equivalent to the first two years of a degree programme) you will be introduced to advanced business modules that further develop the understanding of the business environment you learned in your HN studies. This will take place within the modules ‘Organisational Strategy and Culture’ and ‘Emerging Business Issues’.

You will also be introduced during the first term to the importance of sustainability in relation to the business environment and how it relates to the impact on the planet in the module ‘Sustainable Development Goals in a Business Context’.

In term 2, you will develop your academic research skills in the module ‘Research Design & Methods’, requiring you to critically assess, analyse, and reflect on your learning and research capabilities. The modules ‘Responsible Leadership’ and ‘Sustainable Business Development’ will build on the first term module ‘Sustainable Development Goals in a Business Context’ by looking at different perspectives.

In the second year of study, level 10 (year 4 of the degree and the Honours year), you will critically develop your knowledge and understanding at an advanced level, again focussing on business related areas in the module ‘Brands and Branding’.

This year will focus heavily on Sustainability in the modules ‘Responsible Ethical Management’, ‘Common Good’, and ‘Circular Economy in Business’.

The keystone module for this year is your dissertation or project. This double credit module is a self-directed research project that requires you to write a dissertation or carry out a relevant work-based project agreed by an appointed supervisor.

This final year of study allows you to showpiece to yourself and potential employers what you can achieve at an advanced level of study.

The assessment strategies for each module combine to support your learning skills and personal development at each level, and your employability skills development. Your studies will be supported by quality learning materials available on our UWS learning platform Aula, where you will have access to a range of resources including case studies, questions with solutions, discussion boards, journal articles, quizzes, etc.

The Aula site will also be used for submission of written assessments and class tests. Individual and group presentations will feature as part of the assessment process. Self-learning is key to your success, but you will be supported throughout your time on the programme.

#### **Any additional costs**

Other than course fees, no additional costs are anticipated with this programme.

#### **Graduate Attributes, Employability & Personal Development Planning**

The UK Higher Education Policy Institute (HEPI) published an article in 2023 summarising the key findings of a report ‘An Analysis of the Demand for Skills in the Labour Market in 2035’ by the Nuffield Foundation and University of Sheffield.

This report details how demand for skills will change between now and 2035 based on the expected direction of our economy and available labour resources.

It highlights the essential employment skills needed as:

- Collaboration
- Communication
- Creative Thinking
- Information Literacy (gathering, processing, and using information)
- Organising, planning, and prioritising work
- Problem-solving and decision making

Learning outcomes throughout the programme have been designed to ensure that, in addition to the development of knowledge and understanding of business and sustainability and its components, you will have the opportunity to develop the skills and attributes that are most valued by employers.

The programme has employability embedded into its core curriculum, thereby ensuring you are exposed to the development of your key skills and can reflect on your own personal development.

Employability skills development is continually reinforced throughout the programme. As a graduate of UWS you will be:

- Universal - globally relevant with comprehensively applicable abilities, skills, and behaviours
- Work ready - dynamic and prepared for employment in complex, ever-changing environments which require lifelong learning and resilience
- Successful - as a UWS graduate with a solid foundation on which to continue succeeding and realising your potential, across various contexts

Through studying and graduating from UWS, you will develop attributes across three dimensions:

- Academic – knowledge, skills and abilities related to high-level academic study
- Personal – qualities and characteristics of well-rounded, developed, responsible individuals
- Professional – skills, aptitudes and attitudes required for professional working life in the 21st Century

## Level 10

### Criteria for Award

In line with the Regulatory Framework, for the award of BA (Honours) Business and Sustainability, at least 240 credit points must be achieved, of which a minimum of 120 are at SCQF level 9 and a minimum of 120 at SCQF level 10 (including all core and options), with exception of those required to take the level 9 Research Methods module in place of the level 10 'Common Good' module.

No distinction is awarded at Honours level (Regulation 3.25).
