### **Admissions Criteria**

Candidates must be able to satisfy the general admission requirements of the University of the West of Scotland as specified in Chapter 2 of the University Regulatory Framework together with the following programme requirements:

### **SQA National Qualifications:**

Students will be admitted to the BSc Dental Nursing in line with University Regulatory requirements. For L7 entry, students will require two Highers at grade C or above; or SCQF Level 6 in Dental Nursing or an equivalent SCQF level 6 National Certificate (NC) qualification; or one higher plus SCQF level 7 First Steps to University (UWS) or First Steps to Nursing (UWS).

Relevant qualifications from SWAP programmes, such as SWAP Access to Nursing or SWAP access to Paramedic Science, will also be considered. Applicants who hold Higher National Certificate (HNC) Dental Nursing with General Dental Council (GDC) registration are eligible for articulation into L8. Applicants with Higher National Diploma (HND) Dental Nursing and GDC registration can articulate into L9 of the programme. However, evidence must be provided that the HNC or HND qualification was achieved within the last five years. All applicants meeting the entry criteria for the BSc Dental Nursing programme commencing from September 2024 will commence at SCQF level 7. The new levels 8 and 9 modules will commence from September 2025 for progressing students and articulating routes.

### Other Required Qualifications/Experience

Offer of a place on the BSc Dental Nursing is conditional on successful selection process and subject to health screening and criminal record checks. The process is facilitated by NCL in collaboration with UWS.

UWS has a strong commitment to the Recognition of Prior Learning (RPL) which encompasses both Accreditation of Prior Leaning (APL) and Accreditation of Prior Experiential Learning (APEL) (UWS Regulatory Framework 23/24). The University's procedures involving entry with credit through RPL also apply to all UWS programmes delivered through the Franchise model. All applications involving RPL must be referred to the UWS Programme Leader and Link Tutor.

### Further desirable skills pre-application

#### **General Overview**

This is a UWS approved programme delivered at New College Lanarkshire (NCL), Coatbridge campus under a collaborative partnership agreement. Students on this programme will study at the state-of-the-art dental facility at NCL Coatbridge campus and as UWS students will have access to UWS facilities. UWS has experience of delivering a range of professional Health programmes. NCL has over 30 years of experience in offering dental nursing programmes nationally and internationally.

The BSc Dental Nursing programme prepares potential graduates to begin the study of dental nursing as a discipline. It is provided on a full-time basis over three years with exit awards available following successful completion of year 1 and year 2.

The programme enables dental nurses to meet the requirements of a modern dental care system, working in a multi-professional team and demonstrating leadership and management abilities. The overall aims of the programme are to encourage students to study Dental Nursing as a professional discipline and prepare for Professional Registration with the General Dental Council by the end of year 1. For the first year of the BSc Dental Nursing programme (AY 2024/25), students completing SCQF level 7 will have their achievements mapped to the existing Level 7 qualification with GDC registration through Recognition of Prior Learning (RPL). This will enable GDC registration to be acquired for this cohort. During AY2024/25, GDC accreditation will be sought for the new BSc Dental Nursing programme for future cohorts, commencing from September 2025.

Students will progress to career enhancement opportunities through their ongoing education, at SCQF levels 8 and 9. This will develop higher order meta-skills empowering individuals to navigate complexity, embrace change, foster innovation, and thrive in an interconnected and rapidly changing dental profession, as registered dental nurses. On completion of the BSc Dental Nursing programme, graduates will be qualified to undertake additional skills as outlined in the GDC Scope of Practice (GDC, 2019).

The BSc Dental Nursing programme is underpinned by Enquiry-Based Learning (EBL) (Kahn and O'Rourke, 2004). Using an EBL approach, the student takes an active and pivotal role in learning, by engaging with case studies or scenarios which they explore through enquiry. This approach is very student-centred, since participants in EBL direct their own lines of enquiry and identify suitable methods and data. The process of enquiry encourages participants to draw on prior knowledge and experience; and since many of the exercises are drawn from 'real life', it enables students to relate EBL to the demands of their own contexts and professional commitments. As part of the programme students also participate in work-based learning each year to support the student developing practical skills in a professional environment. These experiences represent contemporary dental theory, practice, and concepts and will draw on theory from each module. Practice learning will take place within private and NHS dental practices. Students will have access to and support from a mentor who is a General Dental Council Registered Dentist or equivalent.

The student dental nurses will work collaboratively and respectfully across their lifespan to promote dental health and deliver person-centred care. Successful students will be adaptable, proficient, and safe practitioners who will have demonstrated the graduate skills required of a highly skilled dental nurse.

The Aims of the Programme:

The overall aim of the programmes is to equip dental nurses with the knowledge, skills, and attributes needed to excel as competent, compassionate, and ethical dental professionals, contributing to the delivery of high-quality patient care. To achieve this, it will:

- 1. Prepare students to be fit for practice and employment to meet the needs of future populations.
- 2. Develop a reflective and resilient practitioner committed to inclusive practice, transformational leadership, continuous professional development and life-long learning.
- 3. Develop graduate attributes including decision making skills, critical appraisal, and research mindedness to influence safe and compassionate practice.
- 4. Profile dental nursing within a multi-professional/multi-agency framework and positively influence an inclusive and collaborative approach to working within an increasingly diverse society.
- 5. Equip the student with enhanced employability skills and the ability to plan a career pathway in the context of a dynamic and evolving dental healthcare system.
- 6. Develop safe, proficient, and adaptable dental nurses who can facilitate health promotion approaches including the nurturing of self-care at individual, family, and community level with an appreciation of needs across the lifespan.
- 7. Develop specific skills, knowledge and understanding of interventions across the lifespan and in dental nursing to include artificial intelligence and advances in technology.
- 8. Prepare the dental nurse to be responsive to the social, political, and economic influences on population health and health care.
- 9. Create a culture that values diversity and individual differences.

### **Graduate Attributes, Employability & Personal Development Planning**

Graduate attributes can be defined as the skills, personal qualities and understanding to be developed through the HE experiences to prepare graduates for life and work in the 21st century.

Through studying on this UWS programme in collaboration with NCL, graduates will develop attributes across the three dimensions which encapsulate the breadth of the learning experience at university level: Academic, Personal and Professional. UWS 'I am UWS' graduate attributes have been developed to reflect the vision that students are Universal, Work Ready and Successful. This is achieved by ensuring the programme can develop relevant academic, personal, and professional attributes within those students undertaking the programme. The 'I am UWS' graduate attributes are incorporated within each module descriptor and associated assessments.

The Dental Nursing curriculum focuses on a student-centred approach which supports and enables the learner to participant in their own learning, prioritising their needs, interests, and abilities to achieve their full potential and to take responsibility for their planning, and career development.

In year one, their focus is on achieving registration status with the regulator, the General Dental Council. Here, the fundamentals of being a safe and competent practitioner are developed via a range of competency based practical skills and evidencing underpinning knowledge achieved. Year two develops a level of mastery and specialism to include

advances in technology, supporting individuals to change patterns and behaviour and skills to aid treatment planning and support diagnosis. Whilst effective engagement with PDP activities in year 3 remains an essential component of lifelong learning and continuing professional development. It facilitates the development of graduate attributes and is fundamentally about empowering, building realistic aspirations and motivating learners to enhanced achievement.

### **Employability**

Dental nursing graduates can pursue roles as dental nurses in various settings, including; NHS and private dental practice; hospitals; community clinics; speciality dental settings; as well as educational settings. Indeed 95% of dental nursing graduates secure employment.

Graduates may choose to specialise in areas such as dental hygiene, orthodontics, oral surgery, radiography or aesthetics. Other dental nursing graduates may pursue careers in dental sales, marketing, education, research, where they can leverage their clinical knowledge and experience to promote dental products, equipment, or services. Dental nursing graduates may also explore opportunities for international employment. Graduates may choose to peruse further education by enrolling in postgraduate programmes such as a Master of Science (MSc) in Nursing, Master of Public Health or Doctor of Dental Surgery (DDS) to become a dentist. By staying informed about industry trends, networking with potential employers, dental nursing graduates can enhance their employment prospects and explore fulfilling career paths in the field of dental healthcare.

### Personal Development Planning

Personal Development Planning (PDP) is embedded within the curriculum with clearly articulated links to module learning outcomes.

The developmental process of PDP and the relevance of reflection are introduced to students as they begin their studies. As students' progress through the programme, they have many opportunities to engage in PDP through timetabled and other modular activities. These activities are designed to help students recognise and evidence their development of skills such as academic writing, critical discussion and analytical thinking. While these are developed and considered in a professional context, students are also encouraged to recognise the wider relevance of these as generic graduate attributes, applicable in a variety of contexts. Students gather this evidence by participating in specific activities related to module content. Effective engagement with PDP activities remains an essential component of lifelong learning and continual professional development. It facilitates the development of graduate attributes and is fundamentally about empowering, building realistic aspirations and motivating learners to enhanced achievement.

### **Graduate Attributes**

To prepare students who are fit for award:

- 1. To develop an autonomous practitioner committed to personal development and lifelong learning.
- 2. To develop graduate level decision making skills and the ability to use enquiry, evidence and research mindedness to influence dental nursing practice.
- 3. To profile dental nursing within a multi-professional/multi-agency framework and positively influence a collaborative approach to learning and the delivery of dental healthcare.
- 4. To equip the student with enhanced graduate and employability skills and the ability to plan a career pathway in the context of a dynamic and evolving dental healthcare system.
- 5. To develop safe, proficient and adaptable nurses who can facilitate dental health promotion approaches at individual, family and community level with an appreciation of needs across the lifespan.

- 6. To develop specific skills, knowledge and understanding of interventions in dental nursing practice including holistic practice, team working and treatment management.
- 7. To foster a commitment to contemporary practice in dental healthcare and to enable students to critically examine the underpinning models, philosophies and theoretical frameworks in dental nursing.

### **Work Based Learning/Placement Details**

Work-based learning (practice learning) will take place throughout the 3-year programme, be embedded within specific modules and linked to theory in all modules. Practice learning experiences represent contemporary dental theory, practice, and concepts within private and NHS dental practice placement and are designed to capture the 'patient journey' within the dental setting. Work-based learning is designed to expose students to care involved to meet the needs of the service user undergoing a range of procedures in that locality.

The programme will include an element of work-based learning in each year. Students will complete 768 hours in placement across the 3 years of the programme (nominally 384 in year 1 and 192 hours in both years 2 and 3 and detailed as work-based learning hours in relevant modules at each SCQF level). The work-based learning experiences will support the students developing practical skills in a professional environment. These experiences represent contemporary dental theory, practice, and concepts and will draw on theory from each module. Practice learning will take place within private and NHS dental practices. Students will have access to and support from a General Dental Council Registered Dentist or equivalent mentor. NCL have long standing partnerships with over 200 dental practices in the Scottish central belt. Students will be supported by personal tutors and will have a work-based assessor assigned by NCL to visit in placement and carry out formal observations of practice. As part of the franchise agreement, NCL will manage the work-based learning requirements including placement audit and allocation, completion of pre-placement requirements including Occupational Health and PVG checks, and insurance requirements. NCL have agreed Service Level Agreements with each placement provider. Through data sharing agreements the UWS Placement Team will have oversight of the processes and will facilitate record keeping through inPlace.

### **Attendance and Engagement**

In line with the <u>Student Attendance and Engagement Procedure</u>, Students are academically engaged if they are regularly attending and participating in timetabled on-campus and online teaching sessions, asynchronous online learning activities, course-related learning resources, and complete assessments and submit these on time.

Module development and implementation is cognisant of legal and professional requirements to ensure that information and guidance for students is inclusive of the known eventualities that may impact on the student's ability to fully engage in learning.

The curriculum is commensurate with legislation (Equality Act 2010)7 and Professional requirements (all Dental Nurses must practice in accordance with the General Dental Council's Standards for the Dental Team (GDC, 2013)8. The (Equality) Act 2010 makes it clear that it is not discriminatory to apply competence standards to a disabled person. However, we can make reasonable adjustments to assist dental nurses to meet those standards.

As a GDC registrant, participants on the programme will be expected to comply with the Fitness to Practice guidelines, recommended by the professional body. This will be evidence through a signed declaration at induction each year. It is expected that all participants will have Protection of Vulnerable Groups status as well as evidence of having completed the relevant health records and immunisation requirements of a practising dental nurse.
